WEIGHT CLASSES

Pure Stock Classes – 3 mph pace: 6000#, 7000#, 8000#, 9000#, 10000#

Antique/Farm Classes – 4 mph Pace: 5500#, 6500#, 8000#

Hot Farm Classes – Unpaced: 8500#, 9500#, 10500#, 12500#, 14500#

SCTWTP Classes: 5500# Open No Turbo

Modified – 6500#

**Truck Classes – Unpaced: 5000#, 5500#, 6000#, Stock, 6200# Open Stock,
6200# Super Stock, 6200# Modified,
Stock Diesel, Open Diesel**

Directions to Pull: One mile West of Wittenberg on North side of State Rd 29. Park your truck and trailer in the pit area immediately adjacent to the track. Food and refreshments available trackside.

GENERAL RULES FOR ALL PULLERS IN ALL CLASSES

1. **Safety First.** Always think safety. Always act safely. Drive slow, look around, think of others. Drive like your father and mother are watching you. **All contestants enter at your own risk.**
2. **Prize Money and/or Trophies** will be awarded to the top finishers depending on the number of entries.
3. **Registration** forms must be completely filled out and signed. Only one pull per class per tractor or truck. Two hooks per tractor if time allows.
4. **Order of pull** within each class will be in reverse order of registration. (Last one registered will pull first.) The pulling order will be posted at the staging area. All drivers should be in line and ready to pull at the start of their class. Time is only allowed to add weights between classes.
5. **Age of Driver** must be 12 years or older in paced tractor classes. Driver 12 - 18 years of age must have written permission from parent or legal guardian to enter paced tractor classes and present a farm safety course certification. Driver must be 18 or older to drive in any unpaced classes.
6. **Fenders** are mandatory. **Kill switch** and **wheelie bars** are recommended but not mandatory except in unpaced classes. Wheelie bars must be strong enough to hold weight of tractor when tested. If no wheelie bars, tractor will be flagged to stop when the front wheels exceed a safe height as determined solely by the Track Official (about knee high).
7. **Tires** may be mounted forwards or backwards. All tires must be on the tractor or truck. No tracks, duals, or chains allowed. For tractors, factory steel wheels allowed but must pull last.
8. **Drawbar Height** not to exceed 20" for all tractor classes. Drawbar must be at least 18" back of center of the rear axle and rigid in all directions. Hitch must be equipped with a 2 ½" clevis or 2 ½" pulling eye. No floating drawbar. Two or three point hitch, if used, may not rise at all during the pull. **Drawbar Height** not to exceed 26" for all truck classes.
9. **Scale** is available to weigh tractor or truck as many times as necessary before the hook. Scale overweight allowance of 50#.
10. **Paced Classes** have an extremely loud air horn system linked directly to the main computer in the cab of the eliminator. It will honk automatically when the actual ground speed exceeds the pace set by the rules and it stops when the ground speed is reduced enough to fall under the pace setting. At the finish line of the track is an extra large digital display updated by computer four times a second which is visible to the tractor driver and the spectators while the puller is driving down the track. The tractor driver can honk the horn as necessary to adjust tractor engine RPM's until the 100 foot mark (double cones), but if the horn honks, even slightly, after the eliminator operator goes past the double cones, the driver is disqualified.
11. **Chain** must be tightened slowly to get the green light. The pull must start with no jerks. All tractors and trucks must be in neutral while hooking up.
12. **Track Officials** have the right to stop a tractor or truck at any time and their decision is final. Track Officials or Pull Organizers have the right to reject or disqualify any entry at any time before, during, or after the pull.
13. **Track Boundary** violation occurs when any wheels of the tractor or truck touch the side boundary line. Pull will be measured from that distance if the driver stops promptly when flagged.
14. **Driver's Butt** must remain in seat at all times. Leaning is allowed.
15. **Pull** stops when the forward motion of the eliminator stops. Weights must be secured. If anything falls off of tractor or truck before it is unhooked, the hook is disqualified. No refunds.
16. **Driver's Meeting** rule changes made by Pull Officials at the Driver's Meeting take priority over these printed rules.
17. **No Crybabies.** Treat the volunteer workers with respect. They aren't getting paid. They are contributing their time. Talk to a track official if you have any questions or concerns.
18. **Have Fun.**

ADDITIONAL RULES FOR ANTIQUE/FARM CLASS (4 MPH Pace) 5500#, 6500#, 8000#

1. **AGE** - Tractors can be any age.
2. **HP & RPM** - Any horsepower is allowed. If RPM exceeds twice original factory specifications, then safety equipment such as bellhousing blanket or flywheel wrap is mandatory. Positive throttle stop and governor are mandatory. In the opinion of the track officials, any tractor operating unsafely will be disqualified.
3. **TIRES** - Any size tires. No front cut tires.
4. **WEIGHTS** - Weights may extend forward no more than 24" in front of tractor casting and backward no more than 24" behind center of rear axle. Weights should be safely fastened.
5. Tractors must have stock block for that make and model. No 12 port heads or M/M 800 parts.

ADDITIONAL RULES FOR HOT FARM CLASS (UNPACED) 8500#, 9500#, 10500#, 12500#, 14500#

1. **AGE** - Tractors can be any age. Tractors may be **MODIFIED** and may run any fuel.
2. **HP & RPM** - Any horsepower is allowed. RPM of 3000 Maximum allowed. Kill switch is mandatory in unpaced classes. If RPM exceeds twice original factory specifications, then safety equipment such as bellhousing blanket or flywheel wrap is mandatory. Working governor is recommended. In the opinion of the track officials, any tractor operating unsafely will be disqualified.
3. **TURBO** - These classes will be divided into two divisions - Non-Turbo Division and Turbo Division. Shift-on-the-go is allowed.
4. **TIRES** - Any size tires are allowed. Front cut tires are allowed.
5. **WEIGHTS** - Weights may extend forward no more than 24" in front of tractor casting and backward the rear weights can be any reasonable distance. All weights must be safely and securely fastened.
6. N.E.W. Tractors, P.I. Pullers, and Special Tractors allowed.

ADDITIONAL RULES FOR MODIFIED CLASS(UNPACED) 6500#

1. **ENGINE** - 500 CI Max, cast iron heads and block, alu-intake or cast, single carb, exhaust must exit vertically, wet sump, no blowers, no injection, no turbines, harmonic balancer must have quarter inch thick steel shielding 360 degrees around it with a hole only big enough to see timing marks, half inch by half inch hole, slipper clutches will be allowed with a approved bell housing or steel shielding of quarter inch thickness is allowed 360 degrees
2. **FRAME** - Must be in good condition/no cracks etc, must have working brake, center of rear axle Forward-14 max length of tractor, wheely bars should be functional
3. **SAFETY** - All rotating parts must be shielded, drive shaft must be shielded around or covered, side shields must cover up to bottom of heads, fire extinguisher mount on tractor within hands Reach, working tether switch on back of tractor, transmission must be inclosed with steel or Blanket, minimum of 3 point safety harness, working reverse light(any color), automatic throttle Return-no foot throttle, N-P safety start switch, fan blades must be covered 360 degrees minimum Quarter inch thick
4. **DRIVER** - Must wear helmet, eye protection, and racing suit
5. **FUEL** - Any kind of gas, no alcohol, no nitrous oxide or nitro-methane fuels allowed
6. **DRAWBAR** - All pulls must be made from a sold drawbar, maximum drawbar height 20 inches, hitch shall be no close than 18 inches from the center of the rear axles to the point the hook of the sled makes contact

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose any RESTRICTED AREA (herein defined as including but not limited to the track, pit areas, infield, approach area, shut down area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in this Tractor/Truck Pull on this date, the undersigned, for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted areas:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoter, eliminator operator, eliminator owners, participants, track operator, track owner, officials, tractor owners, truck owners, drivers, pit crews, and persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releasees", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event;

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

4. THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. Each of the undersigned further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Wisconsin and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
